High-Tech Security Features

1. Describe how you intend to use Smart Schools Bond Act funds to install high-tech security features in school buildings and on school campuses.

An amendment is required due to changes made in scope from the estimates made in the pre-design phase to the actual costs and scope necessary for the construction phase.

The Two-Way radio upgrade requires additional funds to complete the full scope necessary to upgrade the existing radio system. The district currently has issues with its two-way radio coverage in several of the elementary schools and the issues are continuing to expand district-wide.

The Standardized Secured Entrance Devices requires additional funds to complete the full scope necessary. The original construction estimate for the installation of Card Readers, Intercoms, Door Contacts, request to exit sensors, Electrified door strikes and retraction hardware did not account for the additional hardware needed in order to fully lockdown entrances for multiple doors in each school main entrance/office area. The equipment necessary is listed.

The cost of the security door film has been reduced due to the completion of some of the scope of work in other projects and an overestimate of the square footage required to provide the door film for main entrances. No scope has been decreased and the original objective is obtained at the lower project cost.

The reduced cost of incidentals will be moved to the Two-Way Radio Upgrade and Standardized Secure Entrances, projects that are critical to completing the objectives of the Smart Schools Stakeholder Committee and the district.
